


FIGURE 3 - SRP AND DEB T-BAR DESIGN (SOURCE: AUCKLAND COUNCIL 'GD05')





FIGURE 1 - SEDIMENT RETENTION POND FOR 1.5-3ha CATCHMENT PLAN (SOURCE: AUCKLAND COUNCIL 'GD05')




TYPICAL STREAM PLANTING


