Proposed activity(s): Land use consent and water and discharge permits associated

with the provision of 1.5km long, 2.1m internal diameter trunk sewer and associated access shafts and pipe connections that will extend from Bella Vista Road in the west to at 94 Shelly Beach Road (Point Erin Park) in the east, along with associated enabling works, including earthworks, groundwater diversion and dewatering, the disturbance of contaminated land and the discharge of contaminants, construction noise and vibration, and

works to, and the removal of, trees

A copy of the appeal must be served on the Council (Private Bag 92300, Auckland 1142) within 15 working days of the receipt of the decision and on all submitters within 5 working days of lodging the appeal with the Environment Court.
